

SERVICES CONTRACT

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and agreements contained herein, Client hires Contractor and Contractor agrees to work for Client under the terms and conditions hereby agreed upon by the parties.

Any amendment or modification of this agreement shall be in writing, duly executed by both parties no later than 30 days prior to the performance date as specified in the opening paragraph of this agreement and appended to this original document held by the Contractor with a copy of this agreement, along with any amendments or modifications supplied by the Contractor to the Client.

SECTION 1 - WORK TO BE PERFORMED

- I. **Term-** Client agrees to hire Contractor to perform the services and work as stated in Section 1.2 of this agreement.
- II. **Duties-** Contractor agrees to perform work for the Client on the terms and conditions set forth in this agreement as follows: Supply two musicians to perform instrumental and vocal music on the date(s) and times stated in this agreement.
- III. **Performance of Service-** It is understood that the Contractor shall perform the above-mentioned service according to his own methods within the scope of authorization and co-operation requested by the Client. The Contractor shall be provided with reasonable access to the performance location with adequate time to set up for/prior to the performance. Contractor's musicians shall be allowed one fifteen minute break period for every hour of performance contracted, taken at the Contractor's discretion.
- IV. **Cancellation of Service-** Written notice of cancellation shall be provided to the Contractor at least sixty days prior to the performance date. Failure to do so shall entitle the Contractor to payment in full minus any deposit paid to the Contractor. Deposits are non-refundable except in the event a new booking can be scheduled by the Contractor for the contract date.

SECTION 2 - COMPENSATION

- 2.1 **Compensation-** In consideration of all services to be rendered by the Contractor to the Client the Client shall pay to the Contractor the sum disclosed in the opening of this agreement. Said compensation shall be paid in-full upon completion of services contracted herein.

- 2.2 **Withholding-** Contractor is an independent contractor and shall be responsible for his own income/employment taxes.

SECTION 3 - INDEPENDENT CONTRACTOR STATUS

- 3.1 Contractor acknowledges that he is an independent contractor and is not an agent, partner, joint venturer nor employee of the Client. Client shall have no authority to bind or otherwise obligate Contractor in any such manner nor shall Client represent to anyone that it has a right to do so.

SECTION 4 - MISCELLANEOUS PROVISIONS

- 4.1 The provisions for this agreement shall be binding upon and inured to the benefit of the personal representatives, successors and assigns of the parties.
- 4.2 This agreement constitutes the entire agreement between the parties pertaining to its subject matter and supercedes all prior contemporaneous agreements, representations and understandings of the parties. No supplement, modification or amendment of this agreement shall be binding unless executed in writing by all parties and attached hereto.
